Research

Research

- BCS research represents the largest portion—nearly 40%—of all external funding for USF's Academic Affairs.
- BCS is now the home of the Louis de la Parte Florida Mental Health Institute. Celebrating its 35th anniversary in 2009, the Institute is among the nation's largest behavioral health services research centers and houses one of only 13 mental health research institute libraries in the country.
- BCS houses one of the nation's largest compilation of behavioral health services data for use in research in its Policy & Services Research Data Center, and through the Annie E Casey Foundation-funded Kids Count program, now in its 16th year.

Academic

- Three of the four BCS departments/schools with doctoral programs are ranked among the "Top 10" nationally by *The Chronicle of Higher Education* for scholarly productivity.
- BCS is home to one of the few programs in the United States offering bachelors, masters, and doctoral degrees in Gerontology and Aging Studies.
- Several academic journals are edited or co-edited by BCS faculty including *Ear and Hearing*, *Journal of Emotional and Behavioral Disorders*, *Journal of Phonetics*, *The Journal of Behavioral Health Services & Research*, *Topics in Early Childhood Special Education*, & *Trends in Amplification*.

Direct Service & Technical Support

- BCS offers an audiology lab and hearing center for patients from birth to retirement.
- Since 1998, the Florida Kinship Care Center, housed within the School of Social Work, has served thousands of families of children raised by non-parent caregivers throughout Florida. The Center is a statewide information and training clearinghouse for caregivers, agencies and universities.
- The Florida Center for Inclusive Communities (FCIC), a nationally funded University Center of Excellence, serves to improve the lives of the 240,000 Floridians with developmental disabilities.
- BCS is home to the Florida Policy Exchange Center on Aging, a research center with the mission to inform policymakers, media representatives, scholars, and advocates on policies, programs, and services for older adults.
- CARD-USF (Center for Autism and Related Disabilities) serves 2,100 Florida families and 1,500 professionals within 14 counties.

Technology & Assessment Tools

- BCS staff developed technology to address problems associated with wandering behavior and the threat of falling in nursing homes and VA Hospitals.
- BCS staff developed the first empirically-based competence assessment tool (MacCat-CA) for forensic evaluation.

Promoting Effective Services in Communities

- BCS faculty are collaborating on the Disaster Center for Elderly, which serves as a national model to provide transportation options and unique care to underserved elderly populations during threat of evacuation.
- BCS is collaborating with staff from USF Architecture, Public Health, Sociology, Anthropology, the Florida Center for Community Design & Research, area churches, coalitions, government agencies, and student social justice groups to address the problems of affordable housing and homelessness.
- Through efforts of the Florida Suicide Prevention Implementation Project (FSPiP), BCS is enhancing Florida's capacity to initiate, implement, and sustain suicide prevention activities, with a special focus on youth suicide through a widely dispersed school-based guide.
- BCS faculty and staff created Florida's first Criminal Justice, Mental Health, and Substance Abuse Technical Assistance Center to help local governments develop strategies for diverting people from the criminal justice system into appropriate treatment.
- The Jim Walter Partnership Center engages faculty and students in community development work through partnerships with neighborhood-based organizations, civic groups, and policy makers.
- BCS is partnering with USF Colleges of Nursing, Public Health and others to address far-reaching service needs for veterans and their families.
- The Florida/Caribbean AIDS Education and Training Center trains health personnel in Florida, Puerto Rico, and the U.S. Virgin Islands in the diagnosis, treatment, and prevention of HIV disease.
