TELEVISED EDUCATIONAL PROGRAMS

I created the following 30 educational programs, introduced each program, and typically served as the **panel moderator** and **content advisor** for these programs to the Tampa Educational Cable Consortium. As illustrated below, each of these programs featured esteemed members of the professional community in the Tampa Bay area and the State of Florida. The televised conferences included participation by Governor Lawton Chiles, more than 20 judges, including the Chief Judge of the 13th Judicial Circuit (Hillsborough County) and the Chief Justice of the Florida Supreme Court, the State Attorney, the Public Defender in Hillsborough County, State Senators, the SWAT team, and many highly respected prosecutors, defense lawyers, private attorneys, law enforcement officers, and social services and juvenile justice personnel, and USF Presidents.

These classes were filmed in my course, Crime and Justice in America, before an audience of between 300 and 450 USF students and broadcast to thousands of viewers more than a dozen times on four cable networks: Jones Intercable, Paragon Cable, Cablevision Industries, and Telesat Cablevision. The first 28 programs were produced when I taught the class for a several year period (1988-1995). "Crime and Justice in America" was selected from 160 entries to receive the 1995 Southern Sunshine Video Festival Award in the Documentary category. The selection was made by judges after reviewing three of my programs produced during the 1994-1995 academic year. The remaining two were filmed when I taught this class again during the academic year 2000-2001.

Women in the Judiciary. Panel of women who were the first female judges in Hillsborough, Pinellas, and Polk Counties (Judges Susan Bucklew, Claire Lutten, and Carolyn Fulmer, respectively) discussed their career paths and important issues that they faced as a judge and as "a woman on the bench" in their respective circuits. Production date: March 8, 1990.

Women in the Judiciary Part II: The Newly Presiding Judges Speak Out. Opening remarks by USF President Frank Borkowski focused on the increasing representation of women among the judiciary in Hillsborough County. The four newly presiding female judges elected in the fall of 1990 (Diana Allen, Katherine Essrig, Florence Foster, and Claudia Isom) explained their respective roles as county and circuit court judges and discussed issues particularly pertinent to family law and juvenile justice given their respective court assignments and the material recently covered in class. Production date: April 12, 1991.

Women in the Judiciary Part III: Florida Supreme Court Justice Rosemary Barkett. My opening remarks were followed by an introduction of Justice Rosemary Barkett by the USF President Borkowski. Justice Barkett is the first woman appointed to the Florida Supreme Court and will become the Chief Justice on July 1, 1992. Justice Barkett highlighted the role and functions of the Supreme Court and then engaged in a dialogue with students and guests about privacy rights, gender bias in the criminal justice system and legal profession, and children's welfare. Women in the Judiciary Part IV: Career Paths, Values, and Vision. President Borkowski introduced Circuit Court Judges Deborah Behnke and Susan Sexton, who preside over criminal court matters in the 13th Judicial Circuit. The judges discussed educational experiences, career paths, and pertinent issues related to the operational realities of the justice system. Production date: April 6, 1993.

Women in the Judiciary Part V: Career Paths, Values, and Vision. President Betty Castor introduced Circuit Court Judges Cynthia Holloway (Hillsborough County), Susan Schaeffer (Pinellas County), and Lynn Tepper (Pasco County) and Federal Magistrate Elizabeth Jenkins. The judges discussed career paths, gender bias, death penalty, and clemency and other pertinent issues related to the operational realities of the justice system. Production date: March 22, 1994.

Latins in the Judiciary. Opening remarks by USF President Borkowski focused on the contributions made by Latin judges in Hillsborough County. Three judges (the Chief Judge of the Thirteenth Judicial Circuit Dennis Alvarez, Manuel Menendez, and James Dominguez) discussed the influence of their heritage on their lives and career choices and fielded questions issues pertinent to the criminal justice system. Production date: October 29, 1991.

Latins and the Law. Three high ranking members in criminal justice agencies (the Public Defender Julianne Holt, former State Attorney E. J. Salcines, and the Honorable Richard Lazzara, all practicing in the Thirteenth Judicial Circuit) discussed the influence of their heritage on their lives and career choices and fielded questions pertinent to each of their roles and to issues in the juvenile and criminal justice systems. Production date: October 21, 1993.

African Americans in the Judiciary. Opening remarks by USF President Borkowski focused on the contributions made by the four Black judges currently presiding in Hillsborough County. Four judges (one circuit court judge -- Thomas Stringer, two county court judges -- Marva Crenshaw and Perry Little, and one federal district court -- Charles Wilson) discussed the influence of their heritage on their lives and career choices and fielded questions from the audience. Production date: February 18, 1992.

Crack and Crime in Our Community. Panel of experts discussing the problem of crack cocaine and the response of the Tampa Bay community consisted of top ranking staff from the judiciary (Honorable Harry Lee Coe), State's Attorney's Office (Michael Peacock), the law enforcement community (Chief Robert Smith), and the Medical Examiner's Office (Dr. Charles Diggs). Production date: October 10, 1989.

Child Abuse and Volunteerism. Panel of agency staff and volunteers serving abused and neglected children discussed ways that individuals could help these children. Representatives included staff and volunteers from the Volunteer Center of Hillsborough County, State of Florida Department of Health and Rehabilitative Services Foster Care in the Sixth District, Thirteenth Judicial Circuit Guardian Ad Litem's Office, and the Child Abuse Council. Production date: September 25, 1990.

Death Penalty Debate. Proponent and abolitionist perspectives on the death penalty in the United States were presented in a fierce and fiery debate by two nationally known lawyers. The merits of the capital punishment were presented by one of the top ranking members of the State Attorney's Office in the Thirteenth Judicial Circuit (Lee Atkinson); the lack of merits was argued by a legal scholar in the Department of Criminology, University of South Florida (James Halsted). Production date: November 13, 1990.

A Child Advocate's Role of Justice and Injustice. Mr. Jack Levine, Executive Director of the Florida Center for Child and Youth, Tallahassee addressed the crime problem and presented solutions that targeted the roots of crime, especially the lack of social services provided to families and children needing them. Production date: October 24, 1991.

Florida's Inmates Speak Out. Three men and women, all convicted felons serving mandatory sentences for trafficking in drugs, spoke about how they became involved in criminal behavior, what it is like to do "hard time," and what changes need to be made in the criminal justice and correctional systems. The four were participants in SPRY (Save Prevent Reform Youth). Production date: November 7, 1991.

Why Kids Kill Parents. I gave a 90 minute lecture based on my book, *Why Kids Kill Parents*. The lecture focused on explaining why kids kill parents and presented five recommendations for reducing the incidence of child maltreatment, which is the typically the underlying cause of parricide. Recommendations targeted the educational system and the media as the most effective change agents. Production date: April 9, 1992.

Leading personnel in the juvenile justice system in Hillsborough County (Administrative Juvenile Court Judge Vincent Giglio, HRS District Legal Counsel Wes Pardue, and Director of the Juvenile Division of the State Attorney's Office Ada Carmona) discussed problems and procedures re: dependency and delinquency cases in the 13th Judicial Circuit. A leading Child / Adolescent Psychiatrist (Brian Greer) addressed medical aspects of abuse and neglect. Treatment and prevention issues were addressed by all panelists. Production date: April 16, 1992.

Finding Solutions Legislatively. Senator Helen Gordon Davis who has been in the Florida legislature since 1974 (FL Legislature 1974-1988; FL Senate since 1988, running for second term in November 1992) addressed crime and delinquency in Florida, their causes, and solutions. Production date: October 22, 1992.

Sexual Harassment and You. Ms. Wendy Thompson, Associate Legal Counsel, USF Office of the General Counsel, discussed the legal parameters of sexual harassment, its history, significant legislation and legal cases, available remedies, and fielded questions. Production date: December 1, 1992.

Hate Crimes: A Multicultural Perspective. Spokespeople representing different religious, racial, and ethnic groups (Dr. Roy Kaplan, Executive Director of the Tampa Bay Chapter of the National Conference of Christians and Jews; Ms. Harriet Abraham, Regional Director of the American Jewish Committee), the women's community (Dr. Jill Borchert, Asst. Professor of Women's Studies at USF), and the gay and lesbian community (Ms. L. Charlyne Chatham, attorney in private practice in Clearwater) addressed the nature of hate crimes in our community and across our nation, their effects on the specific victims, the groups to which these specific victims belong, and the larger community, and the need for legislation. Representatives from the State Attorney's Office (Mr. Hank Lavandera, Bureau Chief of the Misdemeanor and Juvenile Bureaus) and the Tampa Police Department (Major Ken Taylor, Major of the Detective Division) provided information on the nature of Florida's statutes, court rulings, the incidence of hate crimes in our community, the number of cases prosecuted locally and their outcomes. Production date: October 27, 1992.

An Insider's View of the Criminal Justice System. Attorney Michael Lebron, also known as the award winning radio talk show host Lionel (WFLA 970 AM; Monday through Friday 4-7pm), depicted in a humorous way the operational realities of the criminal justice system and invited students to think about the real issues involved in defending individuals accused of crime. Production date: February 18, 1993.

SWAT Team. A lecture by Detective Richard Walker, member of the Hillsborough County SWAT team, was illustrated with film coverage of the SWAT team in action and live demonstrations by SWAT team members in the Special Events Center. Production date: February 25, 1993.

Corporal Punishment in the Schools. Senator Karen Johnson, Prime Sponsor of Florida Senate Bill 32 to eliminate corporal punishment in the schools, appeared to discuss the reasons to eliminate corporal punishment in the schools with Mrs. Carol Kurdell (Member of the Hillsborough County School Board), Mrs. Dorethea Edgecomb (Principal of Robles Elementary), Mrs. Barbara Dicks (President of the Hillsborough County Council of PTAs), Mr. Paul D'Agostino (Executive Director of the Child Abuse Council), Dr. Howard Knoff (USF Professor with a national reputation in alternatives to corporal punishment in the schools). Production Date: January 20, 1994.

Governor Lawton Chiles: Crime and Justice in Florida. Following my introduction of the subject, President Betty Castor formally introduced Governor Lawton Chiles. Governor Chiles spoke for approximately 25 minutes and fielded questions for another 40 minutes. Production Date: September 22, 1994.

Legal Issues in Education. Participants in this event held during Multicultural Diversity Week and in honor of President Castor's inauguration as USF President included Dr. Rollin Richmond (Dean of the College of Arts and Sciences), President Betty Castor, Mr. Henry Lavandera (Assistant General Counsel at USF), and Mr. Thomas Gonzalez (partner in the law firm of Thompson, Sizemore and Gonzalez). Questions put to the two lawyers by Dr. Heide encompassed issues pertinent to kindergarten through the University level and included ones related to relationship violence, sexual harassment, students' rights, and searches of students' property. Production date: October 13, 1994.

The State vs. the Defense: The Top Lawyers Speak Out. Judge Harry Lee Coe, the State Attorney, and Ms. Julianne Holt, the Public Defender from the 13th Judicial Circuit spoke about their respective roles and offices, and fielded questions on the criminal justice and juvenile justice systems. Production date: February 28, 1995.

Cultural Diversity: Legal Issues and Dilemmas. Participants included USF President Betty Castor, civil rights attorney Warren Dawson, gender equity attorney Adrienne Fechter, employer's labor attorney William Sizemore, and University attorney Henry Lavandera. Questions put to the four attorneys by moderator Dr. Heide and by students focused on issues related to affirmative action, reverse discrimination, gender equity, sexual harassment, political correctness and first amendment rights. Production date: March 30, 1995.

Crime in Tampa: Status and Solutions (a special program for Hispanic Heritage Month, produced by Time Warner). Program featured the following participants: President Judy Genshaft, Public Defender Julianne Holt, Assistant State Attorney Pam Bondi, Tampa Police Dept. and Hillsborough County Sheriff's Office Hispanic Liaisons Octavio Rodriguez and Rocky Rodriguez, respectively. Dr. Heide introduced President Genshaft and served as moderator for a talk show format.
