AFFILIATION AGREEMENT

Students should provide proof of their own medical and professional liability insurance as necessary.

5. _____ may request USF to withdraw any student whose conduct or work performance is not in accordance with _____ policies and standards. USF may withdraw any student whose progress, conduct or performance does not meet USF's standards.

6. _____ and USF may change or add to this Agreement by written amendment executed by authorized representatives of the parties and attached hereto.

7. This Agreement will continue in effect unless/until one of the parties notifies the other of termination. Either party may terminate this agreement in writing with thirty days notice, however, in the case of termination prior to the end of a term of [*INSERT CONTENT TYPE HERE*]/training, students will be permitted to complete their training experience.
